Minutes of the PNMC Board Meeting Conference Call Thursday, December 12, 2019 6 p.m. Alaska; 7 p.m. Pacific; 8 p.m. Mountain Times

Moderator Jeryl Hollinger welcomed everyone and opened the phone meeting with prayer on Thursday at 7:02 p.m. (PST)

1. Executive Conference Minister Report - Katherine Jameson-Pitts

Since the last board meeting, Katherine has been Alaska, Eastern Washington, Arizona, Idaho, California, and Canada.

Katherine presided at the licensing of Jerrell Williams/Salem; the installation of Terry Rediger/Western, and Bryce Miller/Menno; and the ordination of Kevin Chupp/Aberdeen.

She led a Visioning/Planning Workshop at Prince of Peace in Anchorage, AK and preached at Lebanon and Evergreen Heights.

She is working with search committees/leadership teams of Lebanon for an interim pastor to begin in fall 2020 and an interim for Zion beginning March 2020.

Healthy Grant Request was approved for \$850 for interim ministry training for Terry Rediger. A request was denied from Albany for a Sister Care retreat because Albany had already been awarded \$3,000 plus a share of \$500 in 2019 and PNMC supported Sister Care with several thousand dollars in 2018 and 2019.

Current concerns include pastoral transitions, immigration status for Emily Toews of Menno Mennonite (Katherine referred her to an immigration attorney), sustainability of several congregations and reduced giving to PNMC.

2. Minutes of September PNMC Board Meeting

Leonard Nolt moved, and Nelly seconded that we approve the Board minutes of the September 13-14, 2019, Board meeting. **APPROVED.**

3. Finance Report – Dave Hockman-Wert

Balance Sheet – Notes: Line 110206 Everence MM -- This Indexed Money Market account was opened in the past few months in an effort to both support Everence and to receive an improved interest rate for our savings account. It has a balance of \$25,039.95. Line 320808 Healthy Congregations Grant Fund has a balance of \$37,362.61. It shows a zero balance in 2018 because the fund was not set up in QuickBooks until 2019. Total Assets = \$1,171,869.84 as of Dec. 11, 2019.

4. MCC West Coast Board Member – Jeryl Hollinger

Beth Landis (from West Coast MCC) asked if they could move forward with appointing Eva Flores Estrada as PNMC Representative to the West Coast MCC Board to begin a new term running from April 2020 to March 2023. PNMC Board gives their blessing to pursue Eva.
