From the PNMC Conference Moderator, Jack Swaim

Twice a year, leaders from PNMC and their counterparts from other area conferences and constituency groups gather. They meet for two reasons. One reason is to provide counsel, acting in their role as elders, to the MC USA executive board on various matters under consideration. This type of counsel helps the executive board listen to, and stay in closer touch with, the views of conferences and congregations across our denomination. A second reason for CLC meetings is to equip leaders—through worshiping together nurturing mutual relationships, and sharing helpful ideas that they can take back to their respective conferences.

In late March, Eric Massanari (PNMC Executive Conference Minister) and Jack Swaim (PNMC Moderator) participated in a threeday CLC meeting in San Antonio. Among other topics, the MC USA executive board asked for counsel on two proposals. One proposal was to give more operational flexibility to Everence and to Mennonite Health Services (MHS) as they carry out their ministries and serve their stakeholders. This proposal would make Everence and MHS ministry partners [as opposed to agencies] more comparable to Mennonite Disaster Service (MDS) and Mennonite Central Committee (MCC), both of which serve a broad range of Anabaptist churches and affinity groups.

A second proposal was to shift the timing of the MC USA delegate assembly from a two-year cycle to a three-year cycle. CLC participants gathered at round tables for dialogue and then summarized their feedback. All in all, CLC supported both proposals and offered suggestions for how to help them be effective. These proposals are in the discussion stage now; they are likely to be among the topics in the forthcoming July 2023 delegate assembly.

One special highlight was sharing challenges and signs of hope during an informal dinner among leaders of our three western conferences (Pacific Northwest, Pacific Southwest, and Mountain States). The discussion was frank and vulnerable—and it reinforced our already strong relationships, sense of mutual trust, and willingness to help each other. Throughout the CLC gathering we benefited from many informal discussions with peers at table groups, during meals, and during breaks.
