#### Dear Friends in Christ,

Perhaps by now you have received information regarding litigation that has been filed by MC USA and 26 other denominations and faith communities against the Trump administration's decision to rescind the Sensitive Locations policy. This federal policy that has protected immigrants and refugees from immigration raids by Department of Homeland Security (DHS), Immigration and Customs Enforcement (ICE) and other federal and local law enforcement personnel in schools and in houses of faith and worship. Any immigrant who lives with you must be treated as if they were one of your citizens. You must love them as yourself, because you were immigrants... LEVITICUS 19:34 "Photos of Immigrants," Carl Purcell I want to share with you that I am working with colleagues and leaders in several denominations here in the PNW, including the ELCA Lutheran church and the United Church of Christ, to draft an open letter that voices support for and solidarity with our immigrant community members, friends and neighbors. Once completed, our hope is that this letter will be sent out to congregations and communities, inviting your signatures if you wish to join us in speaking out in this way. I will share more information as it comes available.

Additionally, the <u>Center for Faith and Justice</u> has made available a nationwide petition that people may sign to speak out against the current policies of the federal government and voice support for honoring the Sensitive Locations Policy. You can find that petition <u>here</u>.

Finally, I want to offer a word of encouragement that arose out of a gathering of MC USA conference ministers earlier this week. We spent much of our time talking about the dangers and risks faced by our immigrant community members, and we were in agreement that the single best way we can respond as the church is on the most localized level. If you have immigrants in your congregation, please check in and discern what will be the most beneficial support you can offer at this time. Please consider connecting with an immigrant advocacy group in your local area or region, and listen for what the immigrant community in your area is most needing. Stand alongside our siblings in Christ with faith, hope and love. We follow and center ourselves on Jesus, who offered his primary attention and presence not to those who represented the powers and principalities, but to those who were among the outcasts, the oppressed and the marginalized. The Body of Christ transcends all borders and boundaries that keep people apart. May

we together be a living and vibrant expression of the Body of Christ in this world. I will close my note with this prayer that **Pastor Megan Ramer** (Seattle Mennonite Church) shared in a recent PNMC meeting: Jesus, amplify the good, disrupt the plans of evil,

show me my place. Amen

# Mennonite Central Committee

MCC has reached a settlement with a couple who allege their employment as service workers was terminated without sufficient cause. The couple had raised concerns about workplace abuse. MCC Abuse Survivors Together (MAST) said in a Jan. 31 release that MCC will pay Anicka Fast and John Clarke \$180,000 CAD (\$124,400 US). MCC neither admits nor denies wrongdoing in the settlement.
